# Forging the new EU agenda

## Progressive Economic Policy Conference

The beginning of a new legislature offers possibilities to re-shape the work plan of European Institutions, adapt the approach to some existing initiatives and put forward new policy initiatives that freshly appointed European Commissioners or Members of the European Parliament would want to champion.

This initiative, as a collaboration between progressive organisations, representatives of the social-democratic movement and trade unions, aims at discussing in a closed-door setting the way to bring forward progressive priorities in some of the important policy areas that the Union will be active on in this new legislature. It offers the possibility to fine-tune organizational priorities, and discuss openly but in a restricted setting. In short, the sessions will be designed to reflect on how to give a real bite to progressive political priorities into key areas of work.

The conference consists of six main roundtables on key economic policy challenges facing the EU as well as sessions on how to support workers in the transition to defend the Green Deal and on the future of the gender equality agenda (see draft program overleaf). Further, several key priorities of progressives and trade unions are addressed transversally across the conference:

- Continuing the social agenda anchored to the European Pillar of Social Rights
- Protecting and expanding the EU Green Deal principles, policies and reach
- Ensure quality of work and good employment amidst the transitions
- Upholding upward convergence, territorial cohesion and equality

Each roundtable will be introduced by two inputs or presentations by experts, officials or policymakers – 5 minutes each, and selected high-level participants will respond first with comments and inputs. An open discussion will follow.

Each roundtable will have a two-page note to set the context of the expert dialogue and anticipate some policy ideas to be considered and discussed. The notes will be available one week prior to the event.
