

László ANDOR is Secretary General of FEPS. An economist and former EU Commissioner for Employment, Social Affairs and Inclusion (2010-2014), Andor has been head of the Department of Economic Policy at Corvinus University (Budapest), senior fellow at Hertie School of Governance (Berlin) and a visiting professor at ULB (Brussels) and Sciences Po (Paris). He was the editor of the journal Eszmélet and a regular columnist for Figyelo and Népszava. He has authored, edited or co-edited a dozen books. Andor has also taught at Rutgers

University as a Visiting Fulbright Professor, worked as an advisor for the World Bank on SAPRI, the Budget Committee of the Hungarian Parliament (1998-1999) and the prime minister's office (2002-2005), and was also a member of the Board of Directors of the EBRD. He holds a degree in Economic Sciences from Karl Marx (now Corvinus) University, an MA in Development Economics from the University of Manchester and a PhD from the Hungarian Academy of Sciences. He was awarded Doctor Honoris Causa at Sofia University of National and World Economy and the Legion of Honour by the President of France (2014).



Giacomo BENEDETTO holds a Jean Monnet Chair at Royal Holloway, University of London, where his current project focuses on Europe's crises and recoveries over the last decade. Since his appointment at Royal Holloway in 2006, he has developed research and teaching on the public finances of the EU, publishing in highly ranked scholarly journals. He has provided expertise for the EU institutions, and he has contributed to publications for several EU think-tanks, including FEPS. In 2020, he co-authored an article on the "Rise and Fall of Social

Democracy, 1918-2017" published by the American Political Science Review. Giacomo holds a PhD from the London School of Economics.



James BOOTH is the chief analytics officer of Datapraxis. He is a pollster, political analyst and data scientist who has led research programmes on more than 50 campaigns around the world. Beyond Europe, he has worked on elections in the US, Australia, New Zealand, Canada and Latin America. In 2020, James served as director of Paid Media Analytics on the Biden presidential campaign, where he led a team to target and evaluate more than \$750 million in paid TV, digital and mail communication - ensuring the campaign reached the right

Mohammed CHAHIM is a Dutch member of the European Parliament for GroenLinks-PvdA, currently serving his second mandate as an MEP. He is the vice-president of the Socialists and Democrats group, responsible for Green Deal on Industry, Energy & Climate and Financing the Just Transition. He is a member of the Committee for Environment, Public Health and Food Safety. In his previous mandate, he has served as the rapporteur for the regulation establishing the Carbon Border Adjustment Mechanism (CBAM).



Patrick DIAMOND is professor of Public Policy at Queen Mary, University of London and director of the Mile End Institute. He was formally a research fellow in the Department of Politics at the University of Manchester and Gwilym Gibbon Fellow at Nuffield College, Oxford. He is a visiting fellow at Kellogg College, Oxford and an associate member of Nuffield College. Patrick is a member of the Scientific Council of FEPS and a board member of the Campaign for Social Science. He held a number of senior posts in British central government

between 2000 and 2010, and was formally Head of Policy Planning in 10 Downing Street. He was a Local Councillor in the London Borough of Southwark from 2010 to 2014.



Hedwig GIUSTO is a senior research fellow at the Foundation for European Progressive Studies (FEPS), working predominantly on migration and the Balkans. Since September 2020, she has been editor-in-chief of *The Progressive Post*, the magazine run by FEPS. She holds a PhD in History of International Relations from the University of Florence and an MSc in History of International Relations from the London School of Economics.



Daphne HALIKIOPOULOU is chair in Comparative Politics at the University of York. She is interested in party politics and voting behaviour with a focus on the far right, populism and nationalism in Europe. She is the author of "Understanding right-wing populism and what to do about it", *The Golden Dawn's 'Nationalist Solution':* explaining the rise of the far right in Greece and numerous articles on European far-right parties. Her research appears in the Journal of European Public Policy, Perspectives on Politics, European Journal of

Political Research, West European Politics, Journal of Common Market Studies, European Political Science Review, Journal of Ethnic and Migration Studies, Government and Opposition, Environmental Politics and Nations and Nationalism among others. Her

article "Risks, costs and labour markets: Explaining cross-national patterns of far-right party success in European Parliament elections" has been awarded Best Paper from the American Political Science Association (APSA). She is a member of the PopuList team, joint editor-in-chief of the journals Nations and Nationalism and Political Studies, and coeditor of the Springer book series in Electoral Politics. She holds a PhD from the London School of Economics.



Christos KATSIOULIS studied History and Political Science at the University of Trier and the Aristotle University in Thessaloniki. He obtained his MA in International Relations from the Institute for Political Science in Trier, where he also taught international relations and foreign policy from 2003 to 2005. Alan MATTHEWS is Professor Emeritus of European Agricultural Policy at Trinity College Dublin, Ireland. Gintautas PALUCKAS has been the Prime Minister of Lithuania since December 2024. Paluckas served as Deputy Mayor of Vilnius (2015-2019), as the chairman of the Lithuanian Social Democratic (2017-2021) and has been a member of the Seimas since the 2020 election. He has been a member of LSDP since 2003. Paluckas has been the director of EMUS UAB (2010-2017), director of the Vilnius City Municipality Administration (2007-2009), adviser to an MEP (2005-2007) and a senior specialist at the State Social Insurance Fund Board under the

Ministry of Social Security and Labour, Insurance Organisation Division (2003-2005). In 2003, he graduated from the Vilnius University Faculty of Mathematics and Informatics and from International Business School in 2004.



Tomáš PETŘÍČEK is the director of Progressive Analytical Centre, an independent Prague-based think-tank. He is also a senior nonresidential fellow at the Centre of Global Political Economy of the Institute of International Relations in Prague and an associated researcher at the Sciences Po Paris. He is an International Relations and Geopolitics lecturer at Charles University in Prague's Faculty of Social Sciences. He served as a Minister of Foreign Affairs of the Czech Republic between 2018 and 2021. He received a PhD in International Relations from the

In 2020, she was co-chair for a thematic group on 'Strategic Technologies' for Science, Technology, and Innovation Policy (STIP 2020) Report, Office of Principal Scientific Advisor of the Government of India



and the Department of Science and Technology, the Government of India. Dr. Rajagopalan has also been the Technical Advisor to the UN Group of Governmental Experts (GGE) on Prevention of Arms Race in Outer Space (2018-2019) and a non-resident Indo-Pacific Fellow at the Perth USAsia Centre (April-December 2020), and a visiting professor at the Graduate Institute of International Politics, National Chung Hsing University, Taiwan (2012). Between 2018 and 2024, she was a senior Asia defence writer and a weekly columnist for *The Diplomat*, focusing on Asian strategic issues. Dr Rajagopalan has authored, co-authored or edited more than a dozen books and published numerous essays and articles in several peer-reviewed journals.



Maria João RODRIGUES, President of FEPS and former Portuguese minister to Prime Minister António Guterres, is a European politician with a long track record in all European institutions: EU presidencies; Council; European Council; European Commission; and, more recently, European Parliament. She played a relevant role in several big European initiatives: the EU growth and jobs strategy; the Lisbon Treaty; the Eurozone reform; the European Social Pillar; the interface with EU external strategic partners; and the Roadmap for the EU's

future. Recently, she was vice-president of the S&D Group in the European Parliament, where she was in charge of the coordination of parliamentary work and interinstitutional negotiation on the EU agenda. Before joining FEPS in 2009, Skrzypek worked as a PhD researcher and taught at the Faculty of Journalism and Political Sciences at the University of Warsaw (2003-2009). She is an author of over 100 published pamphlets, papers and articles, available in English, German, French, Spanish, Bulgarian and Polish.
